**Grounds:** The Field Trial grounds are located west of Bernardo, New Mexico. Bernardo is between Belen and Socorro on **Interstate 25 at Exit 175**. Take the **Exit 175** ramp to Kiva RV Park on the west side of I-25 and continue south on the access road for 1.5 miles, then at the **T** intersection, turn right (West) on the dirt road and continue for 7.2 miles. Turn right immediately after crossing the cattle guard. From cattle guard proceed 0.7 miles to the Field Trial campgrounds.

**BIG RIGS: Please be careful turning at the cattle guard.**
